NN Insurance Belgium est parvenue à un accord sur la vente d'un portefeuille *closed book* à Athora Belgium

NN Group annonce aujourd'hui que sa filiale NN Insurance Belgium a l'intention de vendre un portefeuille d'assurances vie closed book à Athora Belgium.

Le portefeuille closed book est constitué de polices d'assurance vie qui ne sont plus commercialisées, et représente un montant approximatif de 3,3 milliards d'euros d'actifs et de passifs. L'accord envisagé n'impacte en rien les services ni les garanties que NN propose à ses assurés.

La proposition de transaction simplifiera davantage la structure informatique de NN Insurance Belgium, ce qui lui permettra de se concentrer pleinement sur la mise en œuvre de sa stratégie visant à développer davantage ses activités de protection et de pension, en s'appuyant sur le solide réseau de distribution dont elle dispose sur le marché belge.

Une fois finalisée, la transaction devrait avoir un impact positif sur le ratio Solvabilité II de NN Group d'environ 1 point de pourcentage.

La transaction proposée est soumise aux conditions habituelles, notamment l'obtention des autorisations réglementaires et de concurrence requises et la consultation du comité d'entreprise de NN Insurance Belgium. La finalisation est prévue mi-2022.
